1. EXECUTIVE SUMMARY

1.1 INTRODUCTION

Late Capt. Shri. Shivrampant Damle, the Pioneer of Maharashtriya Mandal, established this Institution with the group of young and fit people in 1924. During those years it was found that the Maharashtriyan youth had to be directed to enter the services i.e. the Armed Forces, in view of IInd World War. With this motive in mind, Capt. Damle took it upon himself to educate and encourage the youngsters in this direction. The mission was to develop and inculcate an attitude towards wellness, which is the quality of life that one leads. This enabled to nurture healthy, strong, courageous youth who were free of any vices and who had a sense of commitment towards the society and the nation. This led to the setting up of special coaching classes for the NDA entrance examination.

All this required to educate and produce good dedicated and committed teachers of Physical Education. An initiative was started in 1932 with the permission from the Government to start a College of Physical Education. This resulted in the establishment of College of Physical Education in the year 1977. It took 45 long years to complete and convince all the authorities. This shows the commitment and dedication of Capt. Damle of Maharashtriya Mandal in achieving his mission.

The Military Officers could not flourish in their jobs as they were lacking in english, so as to overcome this hurdle, Capt. Damle started an English Medium School in 1964. Along with that, he also started a Marathi Medium School. Today, the Institute has one English Medium School at Tilak Road, one at Gultekdi and one Marathi Medium School in the Gultekdi campus with colleges of physical and as well as commerce education. Under his able wings, today Maharashtriya Mandal has flourished in various fields like physical, social and cultural.Maharashtriya Mandal arranges various competitions which motivates children to achieve their goals, to demonstrate determination, creativity and perseverance to overcome challenges and to understand that hard work and commitment leads to a greater chance of success.

1.3 CRITERIA WISE SUMMARY

Curricular Aspects

The college provides undergraduate program in B.Com., affiliated with Savitribai Phule Pune University (SPPU), Pune. The university's Board of Studies updates and revises the curriculum regularly, focusing on knowledge, skills, social development, and employability. As a teaching unit, the college depends on the university for academic and administrative validation but tailors' curriculum implementation to its own resources, goals, and mission. Academic flexibility is supported with supplementary certificate courses. Faculty participate in university-led syllabus restructuring workshops, and the curriculum includes topics like gender sensitization, environmental sustainability, human values, and ethics. Feedback is gathered from students, parents, teachers, and alumni, with additional enrichment activities like industrial visits, guest lectures, and interactions with entrepreneurs to enhance students' skills and knowledge.

Teaching-learning and Evaluation

The college has a transparent grievance-handling mechanism. At the start of each semester, teachers explain the evaluation process for internal and external exams, with an internal exam calendar shared in advance. Exams are supervised, and answer sheets are evaluated by subject teachers within seven working days. Any internal exam issues are resolved promptly, and marks are posted on the notice board. Examination rules are strictly followed, minimizing complaints. Final exam scores are uploaded to the university portal.

To pass, students need at least 40% in both internal tests and the university exams. For a Bachelor's degree, students must accumulate 140 credits, including 132 course credits and 8 credits in areas like value-added courses and physical education.

The college employs experiential, participatory, and problem-solving learning methods to enhance education. Opportunities for guest lectures, seminars, workshops, and co-curricular activities complement classroom learning, supporting a holistic student experience.

Student engagement is enhanced through innovative assessment methods like group discussions, quizzes, presentations, games, and demonstrations.

Research, Innovations and Extension

Recognizing the importance of entrepreneurship in the global economy, the college emphasizes developing entrepreneurial skills among students to prepare them for self-employment and future business ventures. Initiatives include guest lectures on entrepreneurship and self-employment, alongside promoting responsible citizenship and providing access to quality training resources. Various teaching techniques are employed, including group discussions, visits to industries, PowerPoint presentations, graphical exercises, surveying, mapping, journal writing, and tour reports.

Faculty members are encouraged to participate in various online and offline professional courses, including orientation, refresher, short-term, and faculty development programs, both locally and out of state. Some faculty have contributed quality research publications in peer-reviewed, UGC-CARE, and SCOPUS-indexed

journals, though the number remains limited.

Infrastructure and Learning Resources

The college boasts strong infrastructure and academic resources to support its educational mission. It features eight classrooms, a smart classroom, a computer lab, an auditorium with a capacity of 400, a library, administrative offices, and a staff room. Additionally, the college has well-maintained sports facilities for cricket, football, basketball, volleyball, and athletics, along with spaces for indoor games like table tennis and badminton. A gymnasium with modern equipment promotes fitness, while dedicated areas for cultural activities, including music, dance, and drama, encourage student engagement in the arts.

Student Support and Progression

Student grievances are managed by the ICC, Grievance Redressal, and Anti-Ragging Cells, in compliance with Government and UGC guidelines. The college holds annual on-campus placement drives and promotes student progression to higher education and employment. An inclusive environment is fostered through cultural events and sports. The alumni contribute overall support for the college's activities and conducting various programs.

The college provides academic support to the students through the activities like internal tests, study tours, project work, internship, remedial coaching, various competitions, and skill development courses.

Governance, Leadership and Management

The college, affiliated with Savitribai Phule Pune University and governed by Maharashtra's regulations, mobilizes funds through its parent institute. Key stakeholders, including the CDC, Principal, IQAC, and faculty, contribute to quality policies across teaching, research, and outreach. Academic and administrative plans reflect the institution's commitment to its mission, with leadership ensuring alignment with policy statements and action plans.

Faculty participate in institutional decision-making through committees led by the Principal, involving teaching, non-teaching staff, and students. These committees manage college operations, including admissions, academic coordination, exams, research promotion, infrastructure development, staff appointments, record maintenance, cultural activities, and the promotion of national integrity and social responsibility.

Institutional Values and Best Practices

The college aims to foster student independence and confidence, organizing various gender sensitization and awareness programs in collaboration with the IQAC. It celebrates national and international commemorative days and events, such as Mother Language Day, Women's Day, Independence Day, International Yoga Day, and World Environment Day.

To promote energy conservation, the college has implemented the use of LED bulbs and tube lights in offices, laboratories, and classrooms, receiving certification from a national agency for its energy audit. It also maintains separate garbage bins for biodegradable and non-biodegradable waste and has taken measures to

create a green campus, including tree planting and the establishment of pathways for easy movement.

The college strives to create a plastic-free environment, enhancing the campus with trees and plants to emphasize the importance of nature. Green and environmental audits are conducted regularly. Additionally, students participate in tree plantation and plastic awareness campaigns as part of the college's commitment to environmental promotion. The institution also fosters an inclusive environment that encourages tolerance and harmony across cultural, regional, linguistic, communal, and socio-economic diversities.

Institutional preparedness for NEP

1. Multidisciplinary/interdisciplinary:	The National Education Policy aims to offer high- quality education to develop the nation's human resources. In alignment with this vision, our affiliating university, Savitribai Phule Pune University (SPPU), has introduced the Choice Based Credit System (CBCS) for all programs. As our college is affiliated with SPPU, it does not have
	academic autonomy to design its own curriculum. However, the college is planning to introduce interdisciplinary certificate courses to benefit students. SPPU has already taken steps toward a multidisciplinary and interdisciplinary approach by revising the undergraduate curriculum in 2024. To foster holistic academic development, an

	interdisciplinary curriculum has been proposed, allowing students the freedom to choose from a range of programs offered by the college in future.
2. Academic bank of credits (ABC):	The Maharashtriya Mandal's College of Commerce is affiliated with Savitribai Phule Pune University (SPPU), Pune. The college follows the Academic Bank of Credits (ABC) system as per the university's guidelines. SPPU introduced the Choice Based Credit System (CBCS) across all programs in 2019. Under CBCS, students are required to earn some additional credits, beyond the compulsory credits from core courses offered by the university. To support students in this, the college has appointed specific subject teachers to oversee the accumulation of these additional credits. Students are encouraged to earn credits through various online platforms, and these credits are verified and submitted to the university by the respective teachers via an internal mark's entry portal.
3. Skill development:	The college places a strong emphasis on promoting value-based quality education, aiming to foster positivity among students through the introduction of skill development add-on courses. To instill an optimistic outlook, the college organizes value-based programs such as Human Rights Day, Voter Awareness initiatives, Environmental Issues discussions, Gender Sensitization workshops, and Yoga sessions. Additionally, the college is in the process of signing a Memorandum of Understanding (MOU) with various industries to provide students with practical knowledge and develop skills that meet industry requirements.
4. Appropriate integration of Indian Knowledge system (teaching in Indian Language, culture, using online course):	India, being one of the most multilingual and multicultural countries in the world, takes pride in its diverse languages and cultures, which form a rich heritage to be passed down to future generations. In support of this cultural diversity, the college offers various Indian languages such as Marathi, English, and Hindi as subjects in its degree program. Additionally, the college celebrates a wide range of cultural programs, events, ceremonies, special days, and festivals to instill moral and social values in its students.
5. Focus on Outcome based education (OBE):	The college recognizes that the pursuit of knowledge is a lifelong journey and aims to help students

	cultivate a positive attitude and essential qualities for a successful life. In line with Savitribai Phule Pune University's guidelines, our college implements the Outcome-Based Education (OBE) system. The college seeks to standardize and enhance the OBE framework to ensure that students acquire the skills necessary to meet global standards. One of the key program outcomes is to enable students to interpret, analyze, and evaluate information while fostering a sense of responsibility and effective citizenship.

Maharashtriya Mandal's College of Commerce is affiliated to Savitribai Phule Pune University, Pune and it follows the curriculum provided by the University and academic calendar. The teaching and other academic activities are done accordingly. The academic schedule for every academic year is created based on the affiliating university's academic calendar

The College ensures effective curriculum delivery through a well-planned process which is studentcentric. Planning for the actual implementation of the curriculum is done at the beginning of the academic year. The time table for each semester is prepared and workload is distributed to each faculty member accordingly. The syllabus of each subject or course is available on university's website. The link to download the syllabus is provided on our college website.

The college has Admission Committee which guide and help students to get admission. The information regarding various subjects, activities, sports, code of conduct, etc. are provided in the prospectus through committee.

Subject allocation is done according to the choice and expertise of the faculties. Lecture schedule and evaluation parameters are finalised after discussion with faculty members as per the University guidelines.

Review for syllabus completion is taken by Principal periodically. IQAC ensures timely completion of curriculum each semester.

Effective USE of ICT by each teacher ensures fruitful delivery of the curriculum to students. College ensures participation of students in field work/visit, and projects as a part of experiential learning. Students successfully complete value-added courses on the different platforms and college level.

For continuous internal assessment and evaluation, appropriate time tables are prepared for all the classes of the respective programs in consultation with the HODs and Examination cell. The continuous internal assessment work is done according to Savitribai Phule Pune University rules and regulations. Examination schedule and assessment pattern are communicated to the students through notice board.

The respective Subject Teachers conduct the continuous internal assessment as per the requisite of the concern subject content. The result of the examination is displayed on the notice board after overall assessment and evaluation of the respective students. If any student has any query or grievance regarding the allocation of marks, then proper resolution is provided. Finalised marks are verified by the HODs,

College Exam Officer, Principal and Exam Committee members. After all verifications, the internal marks are entered in the affiliating University Portal.
